## Providing a complete utility management service



TRILITY in collaboration with Coliban Water managed, maintained and operated over 46 reservoirs and water storage basins across north central Victoria which provided water and wastewater services to urban and regional customers across 49 towns.

# Wholly owned by TRILITY, Campaspe Asset Management Services (CAMS) provided services for regional Victorian water utility Coliban Water.

Coliban Water has a significant portfolio of water and wastewater assets including:

- 19 water treatment plants
- 13 water reclamation plants
- 227 water and wastewater pumping stations
- Approximately 2,351km of water mains
- Approximately 1,785km of sewer mains
- Approximately 438km of rural irrigation channels

The scope of work was essentially managing and operating Coliban Water's assets and infrastructure including:

- The provision of water and wastewater Operations and Maintenance (O&M) services for treatment plants, pumping stations and networks
- Managing and undertaking meter reading, billing and revenue collection
- O&M of the Bendigo Recycled Water Factory, which substitutes up to 10,000 ML/d per year of potable water demand from irrigation, restricted domestic and industrial users, with recycled water
- Providing inputs into the asset management process
- Maintaining and managing operational and asset management data
- Providing IT services

CAMS also separately delivered additional capital works for Coliban Water.



## Who

Coliban Water is one of the largest Victorian regional urban water corporations, covering approximately 20 per cent of north central Victoria.

It manages, maintains and operates 46 reservoirs and water storage basins across north central Victoria and provides water and wastewater services to urban and regional towns.

## What

Campaspe Asset Management Services (CAMS) provided Operations and Maintenance (O&M) services to Coliban Water.

## Where

Located in Victoria, covering a 16,550km<sup>2</sup> area from Trentham in the south to Cohuna in the north.

## Why

Coliban Water sought an experienced water utility partner to manage and operate their water and wastewater assets and services providing input into the asset management process and trade waste compliance monitoring.

The contract also included billing and revenue collection and the management of IT services.
