Riverland Water brings joy to child victims of domestic violence

Riverland Water will donate \$10,000 to Centacare to assist with the development of a new playground at the Berri facility operated by the Riverland Domestic Violence Service.

The funds were raised at Riverland Water's annual Golf Day, an event that highlights the company's commitment to community development activities in the region. Riverland Water is a joint venture between TRILITY and AMP Capital.

Riverland Water Chairman Merv Peacock said the company in collaboration with its clients and contractors had raised in excess of \$40,000 for community projects in the region over the past five or so years.

"Each year we select a group or organisation to support and we're always delighted to see the difference our donations will make," Mr Peacock said.

"In the past, together with our clients, partners and suppliers have raised and donated money to aid in the rebuild of Waikerie Community Hotel, a Telemetry machine at the Berri Hospital, a Chemotherapy Chair at the Berri Hospital, upgrades to the Loxton Waikerie Men's Shed and funds to help budding gymnasts at Berri District Youth Club follow their dreams.

"We hope this new playground will bring a little fun and joy to these children at such a difficult time in their lives."

Centacare Senior Manager of Domestic Violence & Homelessness Services, Desi Alexandridis, said the organisation was overwhelmed by the generosity.

"We were blown away by how much Riverland Water raised. The new playground at our Berri facility will be a huge hit with the kids. We're very grateful to Riverland Water and all involved," Ms Alexandridis said.

TRILITY Managing Director and Riverland Water Board member Francois Gouws said the annual golf day has proved a huge success.

It also provides us with an important fundraising initiative that establishes a strong link between the company, our clients, our contractors and the communities in which we serve across the region" Mr Gouws said.

Riverland Water will present the club with a \$10,000 cheque on 05 October, 2016.
